WHAT ARE COOKIES? Cookies are small text files sent by the site to the terminal of the data subject (usually to the browser), where they are stored to then be retransmitted to the site at the next visit of the same user. Cookies cannot retrieve any other data from the user's fixed drive nor transmit computer viruses or acquire e-mail addresses. Each cookie is unique to the user's web browser. Certain of the functions of cookies may be requested from other technologies. In this document, the term "cookie" refers to cookies themselves and to all similar technologies.

With the use of cookies, it is possible to record information related to your preferences, such as the web pages browsed or the download of files from our site or other similar actions performed during the navigation of our site.

FIRST- OR THIRD-PARTY COOKIES Cookies may be first- or third-party, where the term "first-party" means cookies developed by the Owner of the site itself, while the term "third-party" means cookies developed by Third Parties, other than the Owner of the site.

NATURE OF COOKIES There are various types of cookies according to their nature:

Technical cookies Technical cookies are used for the sole purpose of "transmitting a communication on an electronic communication network, or to the extent that is strictly necessary for the provider of an information society service explicitly requested by the subscriber or by the user to provide such service (cf. article 122(1) of the Code).

They are not used for other purposes and are usually installed directly by the owner or administrator of the website. They may be divided in:

- navigation or session cookies, that guarantee the normal browsing and use of the website (allowing, for example, the user to make a purchase or to identify themselves to access reserved areas); they are, indeed, necessary for the correct functioning of the site;
- analytics cookies, similar to technical cookies where they are used directly by the site's administrator to collect information, in aggregated form, on the number of users and on how they visit the site, in order to improve the site's performance;
- functionality cookies, which allow the user to browse according to a series of selected criteria (for example, language, the products selected for purchase) in order to improve the service rendered to the user. The installation of such cookies does not require the prior consent of users (for more information, please see the "Management of cookies" paragraph below).

Profiling cookies Profiling cookies are intended for the creation of user profiles and are used to send advertising messages in accordance with the preferences that the user has expressed while browsing the web.

The data subject's consent is required for the use of profiling cookies. In accordance with decree no. 229 of 8 May 2014, users must be able to grant or refuse consent for the installation of profiling cookies where they are present.

In case of third-party cookies, the site has no direct control on individual cookies and cannot control them (it can neither install them directly nor delete them). You can, however, manage these cookies via the browser's settings (follow the instructions below) or through the sites mentioned in the section "Management of cookies".

DURATION OF COOKIES The duration of cookies is dictated by the expiry date (or by a specific action, such as shutting down the browser) set at the time of installation. Cookies may be:

- temporary or session cookies: they are used to store temporary information, allow to link the actions performed during a specific session and are removed from the computer when the browser is shut down;
- permanent (persistent cookies): they are used to store information, for example the access name and password, in order to save users from having to enter them anew each time they visit a specific site. These cookies remain stored in the computer even after the browser has been shut down.

So-called session cookies are not stored once the connection to this website has been terminated. The IT systems used for this site use temporary cookies.

MANAGEMENT OF COOKIES You can deactivate the cookies present on websites by downloading suitable software such as Ghostery (<https://www.ghostery.com>) for your browser and by disabling the use of individual cookies. You may also activate the “anonymous browsing” mode - this is a function that allows you to browse without leaving a trace of navigation data on the browser. This function only allows navigation data not to be stored in the browser.

Alternatively, you can disable/delete cookies by accessing your browser's configuration panel.
